Fabien Sfez, 51, has been General Manager of Fnac France since 2006 during which time he grew Fnac.com, boosted sales and diversified product and service offerings to customers.

He began his career at Accenture, from 1982 to 1991, where he worked on projects in the retail sector. In 1991 he joined Canal+ to oversee and develop the company's subscription and programming information systems. In 2001, he became Senior Vice-President Information Technology of the TV-Film Division that included Universal Studios. In March 2003, he was appointed Fnac's Director of Organization and Information Systems as well as PPR's Director of Information Systems.
